- g. City Administrator Report – Discuss current city activities, upcoming meetings, code enforcement, and other related matter

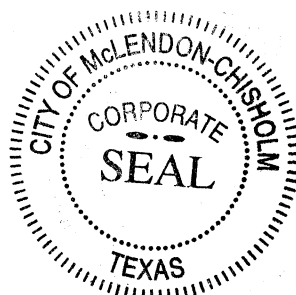
6. CITY COUNCIL COMMENTS – General comments, update on current or upcoming activities, possibly direct City Staff to schedule item(s) for future City Council Meeting
