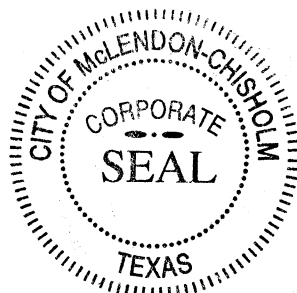


7. ADJOURN
