- e. City Administrator Report – Discuss current city activities, upcoming meetings, code enforcement, and other related matter

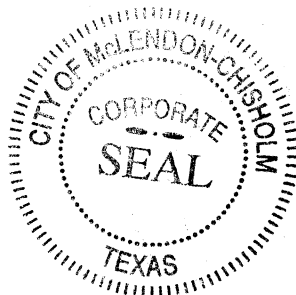


7. ADJOURN
