AN ORDINANCE OF THE CITY OF McLENDON-CHISHOLM, TEXAS, AMENDING THE CODE OF ORDINANCES OF THE CITY OF McLENDON-CHISHOLM, TEXAS, BY AMENDING SUBPART (4) OF SECTION 6.02.002 OF ARTICLE 6.02 ("OFFENSIVE CONDITIONS ON REAL PROPERTY") OF CHAPTER 6 ("HEALTH AND SANITATION") TO PROHIBIT HIGH GRASS AND WEEDS ON REAL PROPERTY; PROVIDING A REPEALING CLAUSE; PROVIDING A SAVINGS CLAUSE; AND, PROVIDING AN EFFECTIVE DATE.
