MAIL TO PARTICIPATE IN ANSWERING QUESTIONS AGREED UPON AT TONIGHT'S MEETING, WHEREBY THE SURVEY SHALL END AT 10:00 AM ON TUESDAY, JANUARY 2, 2017 IN ACCORDANCE WITH THE RULES ESTABLISHED FOR THIS SURVEY BY THE CITY COUNCIL.


