

INVITATION TO BID

## **SH 205 SANITARY SEWER IMPROVEMENTS**

SEALED BIDS for the purpose of furnishing all labor, materials and equipment and performance of all work required in the construction of **SH 205 SANITARY SEWER IMPROVEMENTS** and other improvements incidental thereto, in the City of McLendon-Chisholm ("City"), Texas will be received until **3:00 P.M. on Thursday, September 30, 2020**, by the City of McLendon-Chisholm, 1371 West FM 550, McLendon-Chisholm, TX 75032, at which time in the Council Chambers the proposals will be publicly opened and read aloud and retained by the City for tabulation, checking and evaluation.

The project involves the connection to an existing sanitary sewer manhole in the Sonoma Verde development and the construction of 4' diameter manholes and 12" PVC sanitary sewer line in McLendon-Chisholm, Texas by open cut and by bore with steel encasement pipe. The plans that accompany this manual show a base bid route of 3,300 linear feet of 12" PVC sanitary sewer line and an alternate bid route of 3,154 linear feet of 12" PVC sanitary sewer line, both of which show a connection to the previously mentioned existing manhole located near the main entry of the Sonoma Verde Development near the intersection of SH 205.

Bids shall be submitted in sealed envelopes upon the blank form of proposal furnished. Sealed envelopes shall be clearly marked "SH 205 Sanitary Sewer Improvements- DO NOT OPEN UNTIL **3:00 P.M. on Thursday, September 30, 2020**" and shall be addressed as follows:

Representatives of the Owner and Engineer will be present to discuss the project. Engineer will provide to prospective Bidders of Record such Addenda as Engineer considers necessary in response to discussions or inquiries arising at the conference.

The City reserves the right to waive any minor informalities or irregularities in any proposal. The City also reserves the right to reject any and/or all proposals, to award contracts for individual products or services as may appear advantageous, and to negotiate separately in any manner necessary to serve the best interest of the City. No bid may be withdrawn within sixty (60) days after the date on which bids are opened.
