## **Board & Commission Information**

The McLendon-Chisholm City Council appreciates your interest in serving your community by volunteering your time to serve on one of the City Boards or Commissions. We realize the commitment that is involved in serving in this capacity. Below is additional information to assist you in your decision to become involved. Each Board or Commission plays a very important role in the development of your City and it is important to have board members who are able to attend the necessary meetings to conduct business. In addition to regularly scheduled meetings, members may be required to attend training, work sessions, and joint meetings. Please review this information carefully as you consider which board you can best serve.

## **Board of Adjustments**

This board is comprised of five members and two alternates who are appointed by Council for two year terms. The Board authorizes requests for variances from the zoning ordinance when it is not contrary to the public interest. All meetings are scheduled in accordance with the Texas Open Meetings Act.

## Planning & Zoning Commission

Five commissioners and three alternates are appointed by the City Council to review the Master (Future Land Use Plan) Plan and the Comprehensive Zoning Ordinance of the City, and to analyze matters that affect the development of the City. They are responsible to advise prospective developers as to procedures to follow and ensuring that new developments follow the Land Use Plan and the Subdivision Ordinance. Members work closely with the City Planner to guide the direction of City development. The Planning and Zoning Commission meets on the first Thursday of each month at 6:30 pm. at City Hall. Additional meetings may be necessary from time to time and will be scheduled in accordance to the Texas Open Meetings Act.
